#### WAIVER AND HOLD HARMLESS FORM

- 1. In consideration of activities of **Duc In Altum Retreat** for the dates of **June 23 to June 27, 2025**, herein referred to as "ACTIVITY," at Belmont Abbey College, I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, AND AGREE TO HOLD HARMLESS for any and all purposes SPONSOR; The Southern Benedictine Society of North Carolina, Incorporated; The Board of Trustees for Sponsor; their officers; members; servants; agents; volunteers; or employees (herein referred to as RELEASEES) FROM ANY AND ALL LIABILITIES, CLAIMS, DEMANDS, OR INJURY, INCLUDING DEATH, that may be sustained by me while participating in such ACTIVITY, or while on the premises owned or leased by RELEASEES, including injuries sustained as a result of the negligence of RELEASEES.
- 2. I am fully aware that there are inherent risks involved with this ACTIVITY, and I choose to voluntarily participate in said ACTIVITY with full knowledge that said ACTIVITY may be hazardous to me and my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me as a result of participating in said ACTIVITY including injuries sustained as a result of the negligence of RELEASEES. - 5. In signing this Covenant Not to Sue and Agreement to Hold harmless, I acknowledge and represent that (i.) I have read the foregoing Covenant Not to Sue and Agreement to Hold Harmless; (ii) I have had an opportunity to have it reviewed by my attorney, if I so desired; (iii) I understand it and sign it voluntarily as my own free act and deed; and (iv) no oral representations, statements, or inducements apart from the foregoing agreement that has been reduced to writing have been made. I execute this document for full, adequate, and complete consideration fully intending to be bound by the same, now and in the future.

# Items to bring to Duc In Altum:

- 1. Bed sheets for twin size bed or sleeping bag/pillow (No blankets are provided; please bring your own.)
- 2. Shorter Christian Prayer Book or Breviary (optional, if you have one)
- 3. Bath towel(s)
- 4. Personal items to include all toiletries
- 5. Rubber soled shoes (athletic shoes)
- 6. Attire for Mass dress pants/capris or appropriate skirt/dress, no shorts or jeans
- 7. Attire for day and athletic activities comfortable clothes; shorts should be of a modest length
- 8. Bible and other spiritual reading
- 9. Journal
- 10. Rosary
- 11. Small bag to carry throughout the day (ex. draw string backpack, shoulder bag, etc.)

\*\*All clothes worn should be modest in nature. Please do not wear short shorts, skirts, or dresses.\*\*

Online registration for Duc In Altum is open until **June 9, 2025**.

Applicants between the ages of 16 and 19 will be accepted on a first-come, first-serve basis. Once our spaces are filled, we will create a wait-list in case any vacancies arise.

After you submit your registration, you will receive an email receipt. This email receipt **does not mean** that your attendance is confirmed.

You will then receive a **second email** stating one of the following:

- 1) That your attendance is confirmed and you may plan on attending DIA 2025; or
- 2) That your registration has been placed on a temporary "wait-list," and you will need to await a third email stating whether you can attend; or
- 3) Space is not available this year.

If your registration is placed on the temporary "wait-list," an email will be sent to you by **June 9** at the latest to inform you if space becomes available.
